**WHAT WE FUND**

The Robert Chinn Foundation Grant Program awards up to \$10,000 for specific projects and programs devoted to art, culture, health, and youth development. Requests for operating grants, capital campaigns, or to individuals will not be considered. The fund supports nonprofit organizations nationally serving children and families. 2016 grantees are not eligible to apply this year.

**CRITERIA**

The RCF Grant Program will consider requests for program funding in the following areas:

- **Art, Culture, and Performing Arts:** support programs that provide equitable access to diverse arts experiences.
- **Health:** support programs that provide outreach, access, and education to Asian and Pacific Islander communities.
- **Youth Development:** support athletics, mentoring and leadership programs.
